Sub: - Status of Desh Bhagat University, Amloh Road, Mandi Gobindgarh, Punjab

Sir,

With reference of your letter dated 09.08.2014 on the above subject, I am directed to inform you that Desh Bhagat University, Amloh Road, Mandi Gobindgarh, Punjab has been established by an Act or State Legislature of Punjab as a Private University and is empowered to award degrees as specified under Section 22 of the UGC Act through its main campus at regular mode with the approval of Statutory Bodies/Councils, wherever its required.

Desh Bhagat University, Amloh Road, Mandi Gobindgarh, Punjab is not authorized to open study centre/ off campus centre beyond the territorial jurisdiction of the state as per the judgment of Hon'ble Supreme Court of India in case of Prof. Yashpal Vs. State of Chhattisgarh. The University cannot open its centre(s) even within the state as per the provision of UGC (Establishment of and Maintenance of Standards in Private Universities) Regulations, 2003 without the approval of UGC.

The UGC has not granted any approval to the University to open off campus/study centre.
