

Powers & Functions of the Board of Management

- 1) The board may delegate to any officer or authority of the University any of the powers conferred on it by the Act or by the Statutes to be exercised with such restrictions and conditions as it may deem fit to impose with the approval of the Governing Body/Chancellor.
- 2) The Board may make recommendations from time to time to ensure that proper standards of teaching and research are maintained.
- 3) The questions to be considered in a meeting of the Board shall be decided by a majority of votes of the members present. The Chairman of the Board shall be entitled to vote on any question and if the votes are equally divided, he shall have the right of casting vote.
- 4) The notice of meeting of Board of Management be ordinarily sent to the members at least 07 days before the date of the meeting to be held except in case of an emergent meeting.
- 5) The Board of Management shall have the power to call special invitees to the meetings with the approval of the Chancellor.
- 6) All members of the Board of Management except the ex-officio members shall hold the office for the period of two years.
- 7) The Board of Management shall meet at least twice in a calendar year. However, in the event of any exigency, the Chairman may fix meeting (s) as the situation warrants.
- 8) The quorum of meetings of the Board of Management shall be five.
- 9) The Chairman is entitled to exclude any member from being present in the meeting suo-moto which he determines to be detrimental in the interest of the University.
- 10) The Chancellor shall have the power to co-opt any other person(s) on the Board of Management, their tenure and conditions shall be such as given in the order made by the Chancellor for their co-option.
- 11) Registrar shall be the Member Secretary of the Board of Management
